- Quotation valid for acceptance for 2 weeks from quotation date and all prices quoted exclude VAT which will be chargeable at the current rate.
- Unless otherwise stated, this quotation is subject to confirmation of all details and is therefore <u>not a fixed price</u>.
 We reserve the right to make additional charges for additional materials and/or labour for situations that were not apparent prior to the work commencing.
- All access equipment is to be supplied by the customer, free of charge to A2M Safety Limited <u>OR</u> access equipment will be charged to the customer. Therefore, unless otherwise stated, access equipment is **excluded** from our quotation.
- Please note that where individual product or system costs are detailed, these prices only apply when the quotation is ordered and supplied as a complete project. If you wish to amend the scheme details, please contact us to arrange a revised quotation.
- We assume that the structure is capable of withstanding applied loads. Please confirm with your structural
 engineer. Should a revision of our anticipated design be required due to circumstances beyond our control a price
 revision may be necessary.
- All cutting, breaking out and subsequent weatherproofing to be provided by others unless otherwise stated.
- Quotation assumes good access for large size truck up to the building during offloading and that our client will provide a suitable location for delivery & storage of products.
- Unless otherwise stated, we assume that all products ordered are delivered and installed during a single site visit.
- Quotation assumes that there are no materials in the existing structure that contravene C.O.S.H.H. Regulations and, unless otherwise stated, we assume that the installation area is free from obstructions.
- We assume that welfare facilities and power (240V/110V) will be provided free of charge
- Access internally to the structure may/will be required during the site survey/ installation.
- No allowance for Main Contractors Discount has been made.
- A2M Safety Limited cannot be held responsible for damage caused to services within the structure that we were not made aware of prior to commencing work.
- Quotation assumes that the installation is to be carried out from Monday to Friday during normal working hours. Out of hours working is possible for an additional charge.
- Standard payment terms are strictly 30 days net from invoice date, and we will at times, issue invoices for materials delivered to site where applicable.
- For customers that do not meet our required credit rating, a proforma invoice will be issued and must be paid in full prior to works commencing.
- Whilst we will try and be as accommodating as possible when scheduling and rescheduling work, please provide us with at least 72 hours' notice of any change in attendance date. Failure to do so may result in an abortive visit charge of £750 + VAT.
